FREQUENTLY ASKED QUESTIONS/ TERMS AND CONDITIONS OF PURCHASE

Q1. WHERE IS PRECIOUS SMART CITY ASABA

PRECIOUS SMART CITY ASABA is an undeveloped parcel of land located at Akwukwu-Igbo, Oshimili North LGA Delta State

Q2. WHO ARE THE OWNERS/DEVELOPERS PRECIOUS SMART CITY ASABA?

PWAN PRECIOUS, a leading Real Estate development and marketing company with offices in Awka , Anambra State, Enugu State, Asaba Delta State, Lagos State

Q3. WHAT TYPE OF TITLE DOES PRECIOUS SMART CITY ASABA HAVE ON THE LAND?

A Registered Survey & Deed of Assignment.

Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A The land is free from every known government interests or adverse claims.

Q5. WHAT IS THE PAYMENT STRUCTURE?

- A Outright payment of N2.5M per plot payable in 3 months which includes documentation fees (Deed of Assignment, Registered survey plan and Plot demarcation). Cost of is Land N2m, Documentation Fees is N500k
- B N.B: Non_Payment of the monthly instalments as at when due shall be treated as a fundamental breach of the contract which shall result in termination or revocation of the contract/ OR attract default charge of 10% of the month payment.

Q7. IS THE ROAD TO THE ESTATE MOTORABLE?

A Yes. The road to the estate is motorable

Q8. WHAT OTHER PAYMENTS DO I MAKE APART FROM THE PAYMENT FOR THE LAND?

A. Development Fee: The development fee would be determined later. Development fee covers the following:
(I) Creation of good road network (ii) Drainage construction (III) Electrification (iv) Landscaping and beautification etc.

Q9. WHEN DO I MAKE THE OTHER PAYMENTS?

Q16. WHAT HAPPENS IF I CANNOT CONTINUE WITH MY PAYMENT? CAN I REQUEST FOR A REFUND?

A Yes, you can apply for refund only if you have NOT been allocated your plot(s). In the event of a Refund, you are required to give the Company Ninety (90) days' notice to process your refund request and a further Sixty (60) days if the process isn't completed after the first 90 days. The refund shall be processed and paid less 40% (Administrative Fee and Others).
